- Went through 10 (approx.) strategic initiatives under each category

# - All Board members will submit ideas/comments/revisions to the consulting firm

- A few high-level suggestions:

- Organize priorities in a way that that is easier to digest, either by residential/commercial, priorities, timeframe, etc.

- Put some type of verbiage in the plan that iterates that this is a summary of all possible projects. Realistically, 40 programs cannot be done. Those that are deemed most important, and have the ability for funding, are more likely to be accomplished (earlier).

# 4. Finance Committee Update

**a. Financials** – will end the year with approx. \$32k in bank. Great strides have been made over the past 8 months to make sure that the organization ends the year in the positive.

**b.** Audit – The auditors are currently late in completing the audit. The goal is to have the audit complete by the next Board meeting so, if nothing else, existing Board members

c. Organizational Resolution 401(K) – Motion to make an organizational resolution that Mike can sign to execute documents for the 401(K) Profit Sharing plan.
